- (a) To create a healthy and peaceful atmosphere in the society irrespective of caste, creed, race, gender and religion.



(d) The Trustees may appoint from time to time one or more Trustees as additional Trustees to hold office for such period as maybe determined at the time of appointment subject to the maximum number of members of Board of Trustee as per sub-clause 6(b) above

(e) Any vacancy in the office of the Trustees above mentioned or their successors by death, resignation or otherwise may be filled up by co-opting a suitable person by other Trustees and who shall hold office up to such time as may be decided by the board of Trustees.

(f) A Trustee may be removed by the Board of Trustees if it considers that the activities of such Trustee are detrimental to the interest of the Trust. Provided, however, no trustee can be removed under this provision unless;

i. Such Trustee is apprised of precise charges against him/her and is given proper opportunity to explain his/her case;

ii. The resolution removing his/her is passed at least by 3/4th (three fourth) of the Trustees present in that meeting

MANAGING TRUSTEE:-

(7) There shall be a Managing Trustee, from amongst the members of the Board of Trustee, who shall look after the affairs of the Trust.

(8) (a) The tenure of the Managing Trustee shall be three years with the provision for re-election.

(b) The election of the Managing Trustee shall take place before the expiry of the term with one month clear notice to all the members of the Board of Trustee. The Managing trustee shall be elected by simple majority of the quorum. Such meeting shall be of not less than four members of the Board of Trustee.

Mr. Nihar Ranjan Das Shall be the first Managing Trustee of the Trust and also act as Chairman of the trust

- (9) The Managing Trustee shall have custody and controls of all documents, accounts, bank accounts and all the papers relating to the Trust and its properties. For this office/ offices shall be maintained at such place or places as may be decided by the board of Trustees.
- (10) The Managing Trustee shall jointly open and operate Bank account or Account of the Trust along with the Financial Trustee.
- (11) The Managing Trustee may appoint such staff on such terms and conditions as may be necessary in the interest of the Trust. Such appointments shall be placed before the Board of Trustees for its approval in the next meeting.

FINANCIAL TRUSTEE:-

- (12) (a) There shall be a financial Trustee, from amongst the Members of the Board of Trustee, who shall maintain accounts of the Trust.
- (b) The tenure and procedure of election and removal or resignation of Financial Trustee shall be the same as specified above in case of Managing Trustee.
- (c) The Financial Trustee shall jointly along with the Managing Trustee, open and operate current or deposit or other accounts with any scheduled Bank / Banks.
- (d) The Financial Trustee shall arrange for the maintenance of correct books of accounts and payment and asset and liabilities of the Trust. He shall arrange to have the books of accounts of the Trust to be closed on 31st March of every year. Income and Expenditure statement of the year ended on that date and Balance sheet as on that date shall be prepared. Such account shall be audited and certified within two months of from the end of Financial Year by the Chartered Accountant to be appointed by the Board of Trustees every year at Such remuneration as fixed by the Board.

Mr Mr Saroj Kumar Behera Shall be the First Financial Trustee of the Trust and act as Secretary of the Trust.

FUNCTIONS AND POWERS OF THE BOARD OF TRUSTEES

- (13) The Board of Trustees shall have full powers to take all decisions by adopting resolutions. The quorum shall comprise of four members of the Board of Trustees.

(14) In all the matters pertaining to the Trust the decision of the majority of the trustees present and voting shall be final and in case of equality of votes the Managing Trustee shall have a casting vote. It shall be competent however for the trustees to decide matters by circulation.

(15) Subject to the control, direction and superintendence of the board of Trustees, the Managing trustee shall have all and every power for the purpose of properly managing, conducting and administering the affairs of institutions and establishment conducted by the trust, the Managing Trustee shall apprise the Board of Trustees of all the major decisions taken by him/her

(16) The auditors of the Trust shall be appointed by the Board of Trustees on such fees and remuneration as may be decided by the Board.

(17) The Financial Trustee shall arrange for the maintenance of correct books of accounts for receipts and payment and asset and liabilities of the trust prepared, audited and certified within two months of from the end of Financial Year by the Chartered Accountant to be appointed by the Board of Trustees. Such audited accounts shall be placed before the Board of Trustees in their next quarterly meeting.

(18) The Board of Trustees may decide the scheduled bank/ banks with whom the trust may open and operate current or deposit or other account. The managing trustee and Financial trustee shall be jointly authorized to sign all cheques and other documents related to the account(s) in the Bank(s).

(19) The Board of Trustees shall have power and shall be entitled to collect, recover and receive dividends, rents and other income of trust (hereinafter called the trust income) and to pay out all taxes, rates, easements, expenses and outgoings for collection in respect thereof and for the management of the trust and for administering and carrying out the trust thereof.

(20) The surplus funds of the trust shall be invested as may be decided by the board of the Trustees from time to time. The Board of Trustee is entitled to change one form of investment into another form as and when they deem it fit, The Board shall have power to sell any existing asset or raise loan on the on the mortgage or charge of such asset.

Mortgage, assign, transfer or let on lease for any period however long or otherwise dispose of and deal with trust estate including any immovable properties comprised therein of any part thereof either by public auction or by private contract and on such terms and conditions as the Board of Trustees think fit.

(22) The Board of Trustees shall have power to apply for and obtain grants from the government, Local authorities or other authorities banking companies firms, individuals and Institutions on such terms and conditions as may be agreed by the board.

(23) The Board of Trustees shall have full power to compromise or compound all actions, suits and other proceedings and all differences and demands and to refer any such difference or demand to arbitration and to adjust settle and approve all account relating to the trust estate and to execute release and to all other things relating thereto without being answerable or accountable for any loss occasioned thereby.

(24) The Board of Trustees shall confirm to the provisions of the Indian Trust Act 1882 in respect of all matters not expressly provided for herein.

(25) The Board of Trustees may from time to time frame or prescribe any additional rules / bye laws and/or amend, modify, add to and delete such rules / bye laws for carrying out the objects of the Trust. With the approval of at least four members of the board of Trustees the board may make amendments for carrying out the objects of the trust.

(26) The Trustees shall not draw any remuneration or honorarium for the services rendered but may reimburse themselves of expenses actually incurred by them in connection with the works of the trust or their duties relating thereto.

(27) The income and funds of the trust shall be solely utilized towards the objects of the trust and no portion will be utilized for payment to members of the board of trustees by way of profit.

MEETING OF THE BORD OF TRUSTEES:-

(28) (a) The board of Trustees shall meet at least once in a quarter. The Managing trustee shall notify all members of the board of trustee about the date, Time and place of the meeting. Notice may however, be dispensed with if the majority of the trustees agree to waive the notice. A majority of four members may call an emergent meeting.

(b) Agenda of the meetings shall be circulated by the managing Trustee. Minutes of the Meetings shall be recorded by the managing trustee and signed by all members of trustees present.

(c) The Managing Trustee shall preside over the meetings of the board of trustees. In his/her absence it shall be presided by the Financial Trustee.

MISCELLANEOUS:-

(29) The Trustee resigning his office or otherwise ceasing to be trustee shall not by reason of that fact alone be relieved from the liability to the trust or to the co-trustees in respect of his or her acts of commission/ omission or default during the period of Trusteeship. No trustee shall be made liable for the acts or defaults of his or her predecessor but where co-trustees jointly commit a breach of trust and where one of them neglected his or her duties and enabled the others to commit a breach of trust, each is liable for whole of the loss occasioned by the breach.

(30) It is expressly declared that the above trust is a public Charitable trust.

(31) The Trust hereby created is PERPETUAL in existence the Trust-Deed is IRREVOCABLE.

(32) If at any time the object of the trust become impossible for the fulfillment the properties of the trust and funds of the trust shall be transferred to another public charitable trust with similar objects or it shall be utilized for such allied charitable and /or educational purposes as the board of Trustee may decide.


